Investment objective and strategy

The fund seeks to provide long-term growth of capital by investing, normally, at least 80% of its assets in a diversified portfolio of securities of large-cap companies.

How does the fund fit into your portfolio?

- **Designed for a specific risk/return profile.** The strategy targets a 4% excess return and a 5% tracking error versus the Russell 1000 Growth Index.
- **Style purity.** The fund may improve the style integrity of an investor's overall allocation model. The team seeks to provide characteristics that are similar to the Russell 1000 Growth Index by following various product specifications, such as holdings sizes and sector weightings.
- **Risk management.** The team seeks to minimize relative risk exposures associated with industries, style (size, growth/value) and beta.

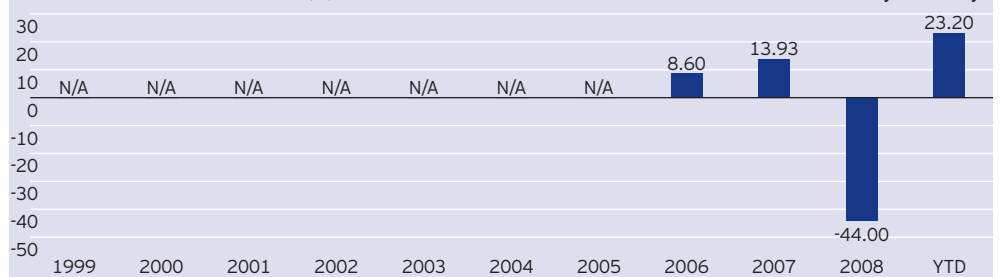

About risk

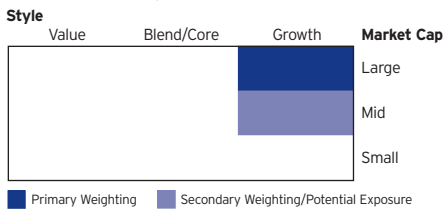

About risk (continued)

The fund invests in "growth" stocks, which may be more volatile than other investment styles because growth stocks are more sensitive to investor perceptions of an issuing company's growth potential.

Interest rate risk refers to the risk that bond prices generally fall as interest rates rise and vice versa.

12-month forward and trailing P/E are calculated using weighted harmonic averaging, which helps avoid extreme results that may occur due to small relative numbers in the denominator. It doesn't exclude extreme values; instead, it reduces the effect of outliers on the aggregate calculation. The **price/book ratio** is the market price of a stock divided by the book value per share. **Return on equity (ROE)** is net income divided by net worth. The **three-year EPS growth rate** is a weighted average of each stock holding's growth rate in earnings per share (EPS). EPS is total earnings divided by the number of shares outstanding. The **five-year dividend growth rate** is the weighted average of each stock holding's annualized percentage rate of growth in dividend yield over five years. **Alpha** (cash adjusted) is a measure of performance on a risk-adjusted basis. **Beta** (cash adjusted) is a measure of relative risk and the slope of regression. **R-squared** (cash adjusted) expresses the proportion of variation in the return of one fund explained by the return of a benchmark. **Tracking error** measures the difference between returns of a portfolio and its benchmark index. The **up and down capture** measures how well a manager was able to replicate or improve on periods of positive benchmark returns and how severely the manager was affected by periods of negative benchmark returns. **Standard deviation** measures a fund's range of total returns and identifies the spread of a fund's short-term fluctuations.

Performance summary

- The fund outperformed the Russell 1000 Growth Index for the third quarter. (Please see the returns table on page 1 for fund and index performance.)
- During the quarter, contributors to the fund's positive relative performance were the industrials and information technology (IT) sectors, while primary detractors from the fund's returns were the consumer staples, energy, health care, and telecommunication services sectors.

Contributors to performance

- Two of the fund's top contributors came from the IT sector. Both **Apple Inc.** and **IBM Corp.** contributed to the fund's positive relative performance for the quarter (6.81% and 5.53% of total net assets, respectively).
- Other top contributors to fund performance were consumer discretionary retailers **Gap Inc.** and **eBay Inc.** (3.46% and 2.25% of total net assets, respectively). **Gap Inc.** is a global specialty retailer offering clothing, accessories and personal care products for men, women, children and babies under the Gap, Old Navy, Banana Republic, Piperlime and Athleta brands.

Detractors from performance

- A top detractor from the fund's performance was telecommunication services company **Sprint Nextel Corp.** (0.61% of total net assets).
- Another top detractor was oil and gas company **Exxon Mobil Corp.** (4.12% of total net assets). **Exxon Mobil Corp.** maintains a portfolio of development and exploration opportunities around the world. As of year-end 2008, West Africa, the Caspian, the Middle East and Russia accounted for approximately 39% of the company's production. The remainder was expected to be sourced from established areas, including Europe, North America and Asia Pacific. **Exxon Mobil Corp.** has an ownership interest in 37 refineries, located in 20 countries.

Positioning and outlook

- The fund seeks to deliver a range of returns, risk and sector exposures that are similar to its benchmark. It targets excess return of 4%, tracking error of 5.0% and beta of 0.8 to 1.2.
- From a sector perspective, the fund is overweight consumer discretionary and health care, while its larger underweights include consumer staples and industrials.
- In this volatile environment, we believe our competitive advantage is remaining focused on stock selection while minimizing biases related to industries, styles and beta.
- Our goal is to deliver a style-pure, large-cap vehicle designed to outperform its benchmark while providing similar risk-return characteristics.
- Markets have experienced a strong recovery during 2009, which continued into the third quarter. We would like to caution investors against making investment decisions based on short-term performance. As always, we recommend that you consult a financial advisor to discuss your individual financial program.
